Applicant: Mr D Robinson

Planning Application No: 3/2019/0030 Grid Ref: 364846 438410

Proposal: Hardcore tracks for farm machinery movements for bale production. Development will reduce soil compaction and mud and slurry leakage into Duddel Brook and Stydd Brook. Location: Squire House Knowle Green PR3 2YS The Council were puzzled why so many tracks were needed for Agricultural purposes and why the tracks would reduce slurry leakage into the nearby brooks.
